

**REGIONAL DISTRICT OF EAST KOOTENAY**  
**BYLAW NO. 3389**

A bylaw to amend Bylaw No. 1641.

---

WHEREAS Bylaw No. 1641 is necessary to regulate and set fees for the Moyie Water System.

AND WHEREAS the Board of the Regional District of East Kootenay wishes to amend the Connections and Fee schedules of Bylaw No. 1641;

NOW THEREFORE, the Board of the Regional District of East Kootenay, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as “Regional District of East Kootenay – Moyie Water System Regulation and Fee Bylaw No. 1641, 2002 – Amendment Bylaw No. 8, 2025.”
2. Schedule A of bylaw No. 1641 is hereby repealed.
3. Schedule B of bylaw No. 1641 is renamed as Schedule A and all references to Schedule B be replaced with Schedule A, attached to and forming part of this bylaw.
4. Schedule C of bylaw No. 1641 is renamed as Schedule B and all references to Schedule C be replaced with Schedule B, attached to and forming part of this bylaw.
5. Section 2.1 is amended by repealing the definitions of **Schedule A** and **Schedule B** and replacing with the following:  
  
“**Schedule A** entitled “Connections”, and **Schedule B** entitled “Fees”, are attached to, incorporated in, and form part of this Bylaw.”
6. Section 7.1 is repealed and replaced with the following:  
  
“7.1 All applications for connection to the Water System shall be made in writing on the application form provided by the RDEK, by the Owner of the property to which the application refers, or by the Owner’s duly Authorized Agent.”

SCHEDULE A

BYLAW NO. 3389

CONNECTIONS  
Moyie Water System

1. CONNECTION FEES

- 1.1 Fees to connect a property to the Moyie Water System are as follows:
- (a) Flat connection fee for occupied and vacant properties:
    - due and payable at the time of application for connection \$ 3,000
  - (b) Flat connection fee for each service lateral installed at the expense of the developer:
    - due and payable at the time of application for connection \$ 500
  - (c) Where actual cost of connection exceeds the flat connection fee outlined in (a) or (b) above, the Owner(s) shall pay the actual costs of connection which include labour, materials, and equipment:
    - deposit due and payable at the time of application for connection \$ 3,000
    - balance due and payable immediately upon completion of connection Actual Costs
- 1.2. Community Halls shall be exempt from paying connection fees.

2. SERVICE DISCONNECTION

- 2.1 Fee to disconnect a property from the Moyie Water system are as follows:
- (a) Service Disconnection Administration Fee \$ 500
  - (b) Service Disconnection Fee Actual Costs

3. METER FEES (if applicable)

- 3.1 Except as provided under Section 6.4 of Bylaw No. 1641, at the time of applying for connection to the Water System, the Owner shall pay to the RDEK a Meter installation fee which is the actual cost of a water Meter, Meter setting fittings, and a remote reading device and connecting cable are supplied by the RDEK.
- 3.2 All Owners must provide a space for a Meter setting in an accessible service inlet location inside the building, unless an alternate location or installation is authorized by the Manager. This Meter setting must include a master shut-off valve, 325mm long copper pipe horizontal run, and a Meter isolation valve.

2. METER RATES

- (a) The charge for the quantity of water used each month shall be calculated at the following rate:

Per 1 cubic meter	\$ 1.30	\$ 1.40	\$ 1.50
Monthly minimum	\$ 64.00	\$ 70.00	\$ 76.00

- (b) Where a Meter is found not to register, the charge will be calculated by the amount of water used during the time the Meter was working or from any other information or source which can be obtained.

3. TURN ON/TURN OFF FEES

4. The rates under Sections 1 and 2 of this Schedule are applicable regardless of whether the respective service is turned on or off.
