#### BACKGROUND/ANALYSIS

Each year, staff review ice fees from interior and regional areas to stay competitive with other comparable facilities. Fees are increased in small amounts each year to ensure fees stay relevant to inflationary costs.

Primary changes for this bylaw amendment include adding specific rates for Registered Groups with Over 50 booked hours in a year for tournaments, games, and events. There is a significant difference in public turnout for Junior Hockey Games compared to Minor Hockey Games. As such, this current bylaw identifies tournaments and games as a different category compared to practices.
