We have raised enough money to buy the bench however, there is a substantial fee for delivery, and we do not have those funds at this point.

Aldridge Community Association members will be doing the ground prep and clearing to provide the spot for the bench.

The grant would be used to pay for the delivery which cannot be done by members as the bench is concrete and too heavy to move without specialized equipment.
